The 147.675 (input)/147.075 (output) repeater is located in Groveland. This repeater is used for the Sunday night net. This repeater uses a 156.7 Hz input tone for CTCSS squelch control.

The W9PIA D-Star 144.505 (input)/145.105 (output) repeater is located in Groveland.

PAARC Board Meeting Minutes - December 6, 2018

The meeting was called to order by PAARC Vice President Mark W9WGN at 7:02 pm. Other club members present were Steve KD9AER, Deb KA4DEB, Tom W8NWG, Jon NM0O, Corey KC9RAV, Neil KC8FYI, and Rich KD9ANU. Also present was a guest, Gary Davis, who is a potential club member, yet to obtain his amateur radio license.

Deb KA4DEB read the minutes from the last board meeting. Neil KC8FYI made a motion to approve those board meeting minutes, which was seconded by Tom W8NWG. The motion was approved.

Neil KC8FYI presented the Financial Report. Tom W8NWG made a motion to approve the report. Steve KD9AER seconded the motion. The motion was approved.

Repeater Updates: Steve KD9AER reported there was a tower climb at Groveland early during the week of Thanksgiving to investigate issues with high SWR. The VHF antenna at the 180 ft location was high, as the mast coupling was loose in a way that made the antenna longer, which was resolved. The VHF antenna at 160 ft also had a problem near the top end – the climber took a recording of the antenna sweep back for further analysis – 98% sure this is due to the jumper from the Heliax to the antenna. A new jumper is being made and is to be installed next week.

Currently the 075 repeater is running on the backup DR-1X repeater, as the original DR-1X repeater has been acting a little flaky. Have learned that Yaesu now offers a new model DR-2X, for \$1100, but with trade-in of our old DR-1X we can get one for \$500, including the shipping cost. Steve to investigate the cost to ship our old repeater to Yaesu in California, to help us decide if we should upgrade.

2019 Programs: Corey is starting to work on programs for 2019, nothing to report just yet.

Possible Red Cross Sale: Nothing else has been heard regarding the possible sale. Fritz WD9FMB reported via text message that the Red Cross owns the tower at the Chapter House building that our antennas are located on.

Club Equipment Checkout Process: Rob KD9DBQ is interested in purchasing the Yaesu FT450 radio, which is now around 15 years old. Rob also reported that something "popped" in the loaner power supply.

Classes: Deb KA4DEB reported she is up to 3 interested parties for the Technical Class. The class will not start until there are 5 signed up. Tom W8NWG agreed to post the Spring General Class on the club's

Facebook page.

SuperFest: Deb KA4DEB reported she is starting to hear from vendors for the 2019 SuperFest, including some new vendors. The reservation has been made with Expo Gardens.

Club Calendar and Website: Deb KA4DEB to work on updates to the website. The website changes for Digital Membership Cards are ready to test.

ARC Antenna Replacement: Given the possible sale of the Red Cross Chapter House, we are holding off on changing any of the antennas on the Red Cross Chapter House tower.

Next Club Activity: Up next is the Christmas Dinner, which will be held at the Alexander Street Steakhouse on Thursday, Dec 13th at 6:30 pm.

Tom W8NWG made a motion to adjourn the meeting. Neil KC8FYI seconded the motion. The motion was approved, and the meeting adjourned at 8:06 pm.

Saturday, January 5, is Kids Day

The first Saturday in January is **Kids Day** — the time to get youngsters on the air to share in the joy and fun that Amateur Radio has to offer.

Kids Day gets under way on Saturday, January 5, at 1800 UTC and concludes at 2359 UTC. Sponsored by the Boring (Oregon) Amateur Radio Club, this event has a simple exchange, suitable for younger operators: first name, age, location, and favorite color. After that, the contact can be as long or as short as each participant prefers.

Look for activity on these frequencies: 10 meters: 28.350 -28.400 MHz; 12 meters: 24.960 -24.980 MHz; 15 meters: 21.360 -21.400 MHz; 17 meters: 18.140 - 18.145 MHz; 20 meters: 14.270 - 14.300 MHz; 40 meters: 7.270 - 7.290 MHz, and 80 meters: 3.740 - 3.940 MHz. Repeater contacts are okay with permission of the repeater owner.

As with any on-the-air activity that includes unlicensed individuals, control operators must observe **third-party traffic restrictions** when making DX contacts. Additional **details** are on the ARRL website.

Australian Scouts will be on the air from special event station VI25AJ January 4 – 14 from the 25th Australian Scout Jamboree (AJ2019), being held in Tailem Bend, South Australia. RTTY Roundup Jan. 5-6, 2019

Contest Details

- 1. Objective: Amateurs worldwide contact and exchange QSO information with other amateurs using digital modes (Baudot RTTY, PSK, FT8 {see rule 7.4}, ASCII, AMTOR, Packet—attended operation only) on 80, 40, 20, 15, and 10 meter bands. Any station may work any other station. Stations may be worked once per band, regardless of mode.
- Date and Contest Period: First full weekend of January, but never on Jan. 1. Begins 1800 UTC Saturday, ends 2359 UTC Sunday (January 5-6, 2019).
 No entrant may operate more than 24 hours out of

the 30-hour contest period.

- **2.2.** If you start at 1800 UTC Saturday and end at 2359 UTC Sunday (a 30-hour period), you MUST take six (6) hours of off time (and the 6 hours must be taken in no more than two (2) blocks).
- **2.3.** All entrants are allowed only one transmitted signal at any given time; alternating CQs on two or more frequencies using the same band and mode is prohibited.

FCC Outlines Impact on its Operations of Potential Funding Lapse

The FCC said in a January 2 **Public Notice** that in the event of a continued partial lapse in federal government funding, it will suspend "most operations" at mid-day on Thursday, January 3. Some systems that have gone dark in prior government shutdowns will remain operational this time, however. That includes the FCC website, although it will not be updated except for matters related to spectrum auction activities and those necessary for the protection of life and property, until normal operations resume. The FCC Daily Digest will continue to appear. The Electronic Comment Filing System (ECFS), the Universal Licensing System (ULS), the Electronic Document Management System (EDOCS), and the Commission Online Registration System (CORES) will remain available, but no support will be provided except that necessary for spectrum auction activity. Processing of Amateur Radio applications will come to a halt, however, said ARRL Assistant Volunteer Coordinator Manager Amanda Grimaldi, N1NHL.

Also down will be the Consumer Complaint Center and the Experimental Licensing System, among several others

Still available will be the Network Outage Reporting System (NORS), the Disaster Information Reporting System (DIRS), the Public Safety Support Center (PSSC), the Licensing Management System (LMS), the Consolidated Database System (CDBS), the Auctions Public Reporting System (PRS), the Auction Application System, and the Auction Bidding System.

"All other Commission electronic filing and database systems will be unavailable to the public until normal agency operations resume," the FCC said.

FCC Amateur Radio Exams are held at the Morton Public Library, 315 West Pershing at 12:00 noon the third Saturday of even numbered months or as noted: Feb 16, Apr 20, June 16, Aug 18, Oct 20 and Dec 15. If no one is there at that time the examiners will leave as they are all volunteers. Walk-ins are welcome. Please bring your original Radio License (if any) and a copy, and the original and a copy of any of any Certificate of Completion (CSCE) not already acted upon by the FCC. Copies are needed to send with your license application. Fee for 2018 is \$15.00. You will also need identification such as a Driver's License, and a Social Security Number. Bloomington:

The schedule for W5YI-VEC Amateur Radio testing dates for 2018 are: 1/27 9:00-11:00am, 3/24 1:00-3:00pm, 5/26 1:00-3:00pm. Testing is held at the Bloomington Public Library Community Room located at the intersection of E. Olive St. and S. East St. Entrance is off S. East St. People should contact Keith a week prior to the test for date and location. Testing begins at 1:00pm. Bring two forms of identification. You will need a copy of your current license plus and CSCE you want to apply. Contact Keith Hanson AC9S at ac9s@hotmail.com (preferred) or (309) 378-4416 for more information.

Note on testing – A Social Security number is now required for all FCC exams.
