The club holds a weekly net on Sunday Evening at 8:30 PM Local Time on the 147.075 repeater. All Amateurs with 2-meter privileges are invited to check in.

Repeaters

The PAARC operates three 2-meter repeaters, which are open for all amateurs with 2-meter privileges. The 146.250 (input)/146.850 (output) repeater is located in Glasford. The repeater uses a 156.7 Hz output tone for CTCSS squelch control.

The 147.675 (input)/147.075 (output) repeater is located in Groveland. This repeater is used for the Sunday night net. This repeater uses a 156.7 Hz input tone for CTCSS squelch control.

The W9PIA D-Star 144.505 (input)/145.105 (output) repeater will be located in Groveland once it is back on the air.

Minutes of PAARC Board Meeting - July 5, 2018

The meeting was called to order by PAARC Club Vice President Mark W9WGN at 6:53 pm. Others present were Gary W9GMK, Bob W9WTF, Deb KA4DEB, Tom W8NWG, Steve KD9AER, and Rich KD9ANU. Dave AB9DL telephoned in shortly after the meeting was underway.

Bob W9WTF made a motion to approve the meeting minutes from June, which was seconded by Tom W8NWG. The motion was approved.

Mark W9WGN presented the Financial Report as submitted by Neil KC8FYI. Gary W9GMK made a motion to approve the report. Bob W9WTF seconded the motion. The motion was approved.

Repeater Updates: A tower climb is scheduled at Moyer's for the week of July 9, which will result in the D-Star antennas for both UHF and VHF machines, at the 160 foot level, and the 147.075 repeater antenna at the 180 foot level (up 20 feet). Additionally, Internet access is to be installed, then the D-Star machines can be activated. Bob W9WTF is to negotiate with Moyer Tower management on the rate for 3 antenna spots on the tower. Gary W9GMK made a motion to pay the asrequested rate for 3 years unless Bob is successful in getting a better rate. Steve KD9AER seconded the motion. A vote was taken and the motion passed. A better jumper will be installed on the 075 antenna.

Discussion regarding the possibility of a Hopedale Repeater has been delayed until the October board meeting.

Storage of Club Equipment: This discussion has been delayed until the October board meeting.

Radio Room Naming: Planning to hold the ceremony at the club meeting, and expect to take photographs to send to Mrs. Huffman.

Red Cross Antenna Upgrades: Mark is to check on the availability of the bucket truck for doing this work.

Programs: This month's meeting program will be focused on digital communications, featuring either Patrick W9GLO presenting on DMR, or Rich KD9ANU presenting regarding Winlink. The August meeting is planned to be a picnic, possibly on Saturday, August 11, at a location to be announced.

Tom W8NWG made a motion to make a \$50 donation to the Hopedale Fire Protection District in recognition of the loan of chairs and tables used at Field Day. Gary W9GMK seconded the motion. The motion was approved. Bob W9WTF to deliver the check to the chief at Hopedale.

Membership: Rich KD9ANU will ask Neil KC8FYI to triple check the treasurer's records for dues payments by an extensive list of those believed to have not yet paid dues for 2018.

It has come to our attention that the Club Constitution has no provision for members who take actions that are detrimental to the club. Several board members are to review documents of other clubs to learn what our options are.

Classes: Deb KA4DEB reported that a class for Technician level licensing will begin in September on the Tuesday after SuperFest. Tom W8NWG is to look for training materials for a possible CW class.

Tents and Banners: Tom W8NWG reported on prices for popups and banners from FastSigns.

SuperFest: Deb KA4DEB reported that the speaker will be Bob Brodovsky K6UDA, the host of The K6UDA Radio Show on YouTube, Elmer with Attitude. The SuperFest tickets and placards have been printed and delivered. The next SuperFest meeting will be on July 26 at 7 PM at the Red Cross.

Illinois Bicentennial Celebration Challenge Special Event: Tom W8NWG reported on plans by the Western Illinois Amateur Radio Club, W9AWE, who is organizing this event. The event will take place starting August 26, 2018 and will end on December 3, 2018. Stations will be on the air multiple times from all 102 Illinois counties during the period using their own calls /IL200. WIARC will award a certificate to all stations who provide proof of at least one QSO with a participating station in each of the 102 counties.

Deb KA4DEB made a motion to adjourn the meeting. Mark W9WGN seconded the motion. The motion was approved, and the meeting adjourned at 8:50 pm.

AREA FCC EXAMS

Morton:

FCC Amateur Radio Exams are held at the Morton Public Library, 315 West Pershing at 12:00 noon the third Saturday of even numbered months or as noted: Feb 17, Apr 21, June 16, Aug 18, Oct 20 and Dec 15. If no one is there at that time the examiners will leave as they are all volunteers. Walk-ins are welcome. Please bring your original Radio License (if any) and a copy, and the original and a copy of any of any Certificate of Completion (CSCE) not already acted upon by the FCC. Copies are needed to send with your license application. Fee for 2018 is \$15.00. You will also need identification such as a Driver's License, and a Social Security Number. Bloomington:

The schedule for W5YI-VEC Amateur Radio testing dates for 2018 are: 1/27 9:00-11:00am, 3/24 1:00-3:00pm, 5/26 1:00-3:00pm. Testing is held at the Bloomington Public Library Community Room located at the intersection of E. Olive St. and S. East St. Entrance is off S. East St. People should contact Keith a week prior to the test for date and location. Testing begins at 1:00pm. Bring two forms of identification. You will need a copy of your current license plus and CSCE you want to apply. Contact Keith Hanson AC9S at ac9s@hotmail.com (preferred) or (309) 378-4416 for more information.

Note on testing - A Social Security number is now required for all FCC exams.
