President's Message

My fellow communicators, we members and friends of Peoria-Area Amateur Radio Club have seen some unique activities in 2020. When, on February 29th, I finished leading my father-in-law's memorial service, I guessed that nothing strange or unwelcome would happen soon after. In fact, my wife and I boarded two airliners on March 1st to get from Rhode Island to Peoria, actions that brought almost immediate consequences when we arrived home. Our crowded aircraft provided a perfect trading place for the coronavirus, and Karen and I were sick for the next two and one-half weeks. Someone on one of our flights was sick ... and overly generous!

Reviewing the next couple of months, we found the TV news populated with people in face masks. Some folks thought it was nothing to be concerned over, but then all the schools emptied out their loads of students. This happened at all grade levels, and suddenly large numbers of children were no longer at their accustomed places, but rather found themselves being home-schooled. Doctors and nurses were hailed overnight as heroes of the day, because the specter of infection was difficult to escape – and they kept on going to work (even though many of them sickened and died in their dedication).

There are signs of change now that summer has arrived. Many citizens of the U.S. are clamoring to venture out and visit restaurants, see movies, and enjoy more of the benefits of being free agents in a bountiful nation. Gov. Pritzger and state health authorities caution us, though, that the "first wave" of the pandemic has not yet finished with us, so we should be careful with our social distancing and continue to wear face masks. Only in this way will we be able to shorten the most difficult parts of the infections and death that stalk the unwise/unbelieving. Of course, the main ones at risk are those who are in that group called "humans." If you're not human, you may have larger problems, though it is nice that you can read this newsletter.

The rubber is scheduled to meet the road in July 2020 for PAARC; American Red Cross has given the club their permission to use the meeting rooms at the chapter house again. Our next club meeting, barring unforeseen circumstances, should occur on the second Thursday of July. I'm not saying that everything is free and clear (masks may still be recommended), but it's a start on the road back to normalcy.

The health department and Expo Gardens are on our radar, mainly because we are still making plans for Superfest 2020. This will be the club's 101st year, and celebration is in order. We can go ahead if both the authorities and Expo Garden's management allow us to schedule a meeting that draws over 2,000 ticket holders to have fun with radio, electronics, computers, and crafts. We're keeping several eyes on the news; we will announce what happens sometime in the next month to month and a half. Stay tuned right here for more news.

Take stock of the sounds coming from your radios, whether there is one of them or you happen to have 25 sitting in your shack. It's good to make a lot "RF pollution" in the summer, so find a band or two that you've not used recently and go find some operators to talk to. It's fun, and it is always worth the effort. Enjoy being a licensed communicator with wide-ranging privileges. There's nothing else like it.

Repeaters

The PAARC operates three 2-meter repeaters, which are open for all amateurs with 2-meter privileges. The 146.250 (input)/146.850 (output) (K9PEO) repeater is located in Glasford. The repeater uses a 103.5 Hz input tone. The 147.675 (input)/147.075 (output) (W9UVI) repeater is located in Groveland. This repeater is used for the Sunday night net. This repeater uses a 156.7 Hz input tone for CTCSS sauelch control. The W9PIA D-Star 144.505 (input)/145.105 (output) repeater and 448.46875 (input)/443.46875 (output) repeaters are located in Groveland.

Membership Information Membership in the Peoria Area Amateur Radio Club is available to any licensed amateur and is administered as follows: Voting Membership: \$25 per calendar year. For our exhibitors who have a prepaid reservation, it will be carried forward to Superfest 2021.



Please bring your original Radio License (if any) and a copy, and the original and a copy of any of any Certificate of Completion (CSCE) not already acted upon by the FCC. Copies are needed to send with your license application. Fee for 2019 is \$15.00. You will also need identification such as a Driver's License, and a Social Security Number.
