# **December is YOTA Month**

### 12/02/2020

The month of December has been designated as YOTA month. The annual initiative sponsored by Youngsters on the Air (YOTA) initially focused on International Amateur Radio Union (IARU) Region 1 (Europe, the Mideast, and Africa), with young radio amateurs taking to the air with YOTA-suffix call signs. YOTA (Youth on the Air) in Region 2 (the Americas) is following step, and K8Y, K8O, K8T, and K8A will be on the air from the US.

The overarching idea is to demonstrate amateur radio to youth to encourage them to get licensed and for younger radio amateurs to get active on the ham bands.

# **PAARC Fundraiser**

Amateur radio means different things to each of us. For some, it is a window to the world. For others it is an opportunity to learn and experiment with electronics, digital and new equipment. For others, it is the public service aspect of weather spotting and emergency communication. For all of us, our hobby is way to connect with others around the world, and especially right here in central Illinois.

The common denominator of amateur radio is fellowship. On the local level we connect through events and activities of the Peoria Area Amateur Radio club and its four repeaters. The W9UVI 147.075 repeater, for example is one of the most popular and most used repeaters in the area. This is due, in large part to a generous coverage area and a well located antenna site.

The Peoria Area Amateur Radio Club celebrated 100 years in 2019. It is the second oldest ham radio club in the country. This is something to be proud of!

Our repeaters are important to central Illinois, especially during this Covid pandemic. They must be always available and reliable. They would not exist without the dedication of members of PAARC. It is important to realize that although the repeaters are free and open to all, they cost money to operate.

PAARC relies on two major sources of revenue: member dues and its major fundraising event: Superfest. Unfortunately, it was necessary to cancel Superfest 2020 due to the Covid pandemic. The previous year's Superfest wasn't as productive as hoped due to torrential rains reducing attendance.

This brings us to 2021. In order to maintain our repeaters, which include tower rent, insurance, broadband, parts, etc., we must keep the revenue flowing. Membership fees alone will not cover tower rent, which leaves us with very few

recommendations from the Board of Directors. Dues are payable by February 1ST of each year.
